 - 6.1. Evaluation Report for the John C. Dunham STEM Partnership School At the last July Governing Board Meeting, Dr. Elizabeth Oyer presented a draft of the evaluation report for the 2015-16 school year. Dr. Oyer asked for feedback from the Board about the report, which is aligned to the logic model's short term and long term goals. The Board came to a consensus to update the logic model for next year. The Board would like to see what the report looks like if it is organized by key stakeholders rather than by the logic model. The Governing Board also asked for a focus on high school performance of JCDSPS graduates, returning teacher impact to the school district, and one or two data points that are compared to school district data points. It was also suggested that the JCDSPS look to the communications staff to assist with telling the story of the school's success.
 - Dr. Eagle will work with Dr. Oyer to finalize the report. The finished report will be shared with District Boards of Education by the superintendents in early September. Dr. Eagle with share with the AU Board, and the evaluation will be posted on the website by mid-September.
 - 6.2. John C. Dunham STEM Partnership School Report: Arin Carter Arin Carter and teacher leader Allison Kapitanoff presented at the National Science Teachers Association's STEM Forum. The presentation was well attended and it increased awareness about JCDSPS. Information was shared about the extracurricular offerings for the 16-17 school year which will include a competitive robotics team, a chess club, two competitive math clubs, and two coding clubs. Carter reviewed upcoming events at the JCDSPS, and she previewed a new format for the teacher-partner meetings.

AU received a grant for "Creating a Better Democracy through Ethical Decision-Making. AU's Institute for Collaboration will create and teach a two-year pilot program.
