Due to COVID 19, Mr. Gordon explained the planning steps The College Board had to work on to be able to provide students, nationwide, the AP exam electronically. When they reviewed the data from Illinois School Districts, they were excited to see D131 had an 87% participation rate, outpacing both the surrounding districts and districts across Illinois.
