## **Minutes**

## **Investment Presentation**

Mr. Michael Prombo introduced Ms. Audra Braski and Mr. Erik Stoltz from PMA Financial Network. Ms. Braski gave a background of the company and their investment procedures. Ms. Braski noted they provide investments as it relates to the liabilities of the school district. Mr. Darby asked for clarification on how PMA works in relation to insuring our funds since they are not a bank. Ms. Braski stated they broker the transactions to move the money into various depositories so they are covered by FDIC insurance. Mr. Stoltz noted that any amounts not entered into banks must have a certain credit rating issued by the S&P that matches the minimum credit rating set by the Illinois School Board.

Ms. Johnson noted that she would like to do better with the yields so we can live off the interest from the referendum bonds. Ms. Johnson mentioned she would like to see quotes on points paid to our various investment agencies and to choose an investment agency based on that data.

Ms. Braski noted that PMA was only investing in money market funds and has only recently moved into fixed rate investments.

Ms. Johnson noted that she thought that had happened earlier. Ms. Johnson noted there are better administrators now, but she would have liked her current investment companies to come to the board to let them know the administrators were not giving the brokerage firms direction.

Mr. Prombo and Ms. Braski noted they have placed some new investments this week. Ms. Braski noted she believes the Riverstreet funds have discretion to made trades on the district's behalf and that PMA has those options to give us as well.

Ms. Johnson noted she would like to see that proposal and has an interest in seeing some investments in Tax Anticipation Warrants. Ms. Braski noted they have those options available as well.

Mr. Stoltz presented the District's specific cash flow and the potential portion of investments that can be moved into long-term investments. Ms. Braski also noted the assets shown do not include the construction bonds, which are held in a separate account.

Ms. Braski then spoke briefly about PMA's Five-Cast product and compiling a five year projection for the District.

Mr. Darby asked how PMA is paid. Ms. Braski responded that PMA is paid by transaction and it is a PMA policy to keep the investments to maturity. Each type of investment has a different transaction fee.

Ms. Johnson would like PMA to review our current investments at Old Second Bank.

#### Grants

Mr. Darby questioned the Fit for Kids grant and what happens to the programs after the grant is used.

It was also noted there was a typo and the \$1,500 should be \$1,500,000. Mr. Prombo noted that the grant required a 10% match component. Orders have been made but the "invoice" did not show the "cost" of the product.

Mr. Prombo noted that he will request the grant administrator be present at the board meeting to answer questions.

# **Advanced Disposals**

Mr. Prombo presented the extension of the Advanced Disposals contract with no new price increases for FY17. However, the board never approved the extension. The proposal to extend the contract through July 31, 2017 will be presented to the Board on December 19, 2016 for approval.
