



SPECIAL EDUCATION STUDENT TRANSPORTATION BID SPECIFICATIONS — Bid #2020-3 ADDENDUM #1

During the mandatory pre-bid meeting, several aspects of the specifications were reviewed.

Additionally, the following items were discussed:

- Drug and Alcohol testing procedures should be updated to include cannabis as it relates to new legislation on its use.
- Districts will receive a credit or debit on each bill for gasoline. The base fuel cost is \$2.50 per gallon. A spreadsheet documenting the adjustments should be included with each billing.
- On page 19, #10 states the Districts will be provided with access to the communication system utilized by the Contractor to communicate with parents regarding routes. After further discussion, this requirement has been eliminated. The aforementioned communication system is preferred but not required.
- The Districts will provide current student rosters to the winning bidder by July 15th of each year. Scheduling of existing students will be completed by August 7th by the winning bidder. Updates will be provided thereafter as needed.

- Vans may be used for routes with less than four (4) students. Van usage may be estimated at 30% of the total student count. Photos of proposed vans must be included in the bid response. Drivers utilizing vans are still required to possess a CDL license. Please note that Exhibit B has been updated to include pricing for vans.
