Board of Director's Message

Dear Tomcats,

It is a time of transition for the Aurora East Educational Foundation (AEEF). Several of our board members have reached the end of their terms. President Ken Darby, Vice President Michael McCue and Secretary Carol Reiseck are retiring from the Board at the close of the school year. Moving forward they will continue to serve as AEEF Advisors, assisting with the transition of our new executive officers and various committees.

Under the leadership of Ken, Michael and Carol, there have been numerous structural and financial improvements to the AEEF, many of which they spearheaded:

Financial Improvements - Over the past four years, the General Fund Balance of the AEEF has grown from \$50,577 to \$181,543, an increase of \$130,966. The AEEF Endowments, earmarked for scholarships and special projects, and administered by the Community Foundation of the Fox River Valley (CFFRV) has increased by \$97,040 from \$1,108,912 to \$1,205,953. We are pleased to report that over the last four years, our financial position has increased an impressive \$228,006.

Accounting Improvements - This year the AEEF has upgraded their financial accounting system. and software. We have transitioned to Quickbooks On-line, with multiple user licenses. This allows those members involved in the financial process to better access, generate and share annual budgets, monthly financial statements, and in depth reports.

Scholarships - Scholarships are the AEEF's top priority. We have steadily increased the number of scholarships awarded over the last eight years. Prior to 2017 only one scholarship was awarded annually. From 2017 to 2020, that number increased to 26 scholarships (\$26,000), and from 2021-2024, the AEEF awarded 92 scholarships (\$137,000). The AEEF's 2025 goal is to award 35 scholarships totalling \$70,000,

In addition, the AEEF is now connecting donors with scholarship recipients. It is reassuring to students that people from our community are investing in the future of East Aurora graduates. It is rewarding for donors to know who received the scholarship they funded. At our annual Giving Tuesday Celebration in November, it was wonderful to connect Tom Strong, who provides an annual scholarship, with Eddie Guerrero, a three-time Careers in Education recipient.

Lastly, the AEEF established the Careers in Technical Education (Trades) Endowment with an investment of \$25,000, which was matched by the CFFRV for a total endowment of \$50,000. The AEEF is proud to fund six CTE Scholarships for 2025.

Programs - AEEF's three biggest programs posted new highs for each event. The **AEEF Annual Golf Outing** netted \$27,639. The **Tom-A-Hawk Turkey Trot** netted \$26,385 and the **Annual Day of Giving** netted the Foundation \$40,765. Truly remarkable totals for 2025.

Though we can not give all the credit to Ken, Michael, and Carol, we are truly grateful for their years of service and outstanding leadership. It takes a team to achieve these kind of results and we are VERY thankful for the many volunteers, donors, sponsors and District 131 team members who contribute to the success of the AEEF.

Over the last nine years, excluding 2020, the AEEF has raised over \$173,000 through the support of the Tomcat community at the annual golf outing. This year, the golf committee netted the highest total to date, \$27,639. Our goal is to raise over \$30,000 next year. The Golf Outing provides the funds for the Annual Mini-Grant program. In 2024 there were four Corporate Gold sponsor donors, Annette Johnson, President of the D131 School Board, Stephen & Dierdre Morcos, Cordogan, Clark and Associates, and DJ Payne Corporation. The 2024 Golf Outing Committee included Ray Torres, Michael McCue, Ken Darby, Kate Mesiacos, Mark Michelini, and several others.

The competition was very fierce, awards went to:

Team McCue (Bobby, Michael, Billy, and Mary) winning the *Low Net Score Mixed Scramble* and Team Johnson (Mark Johnson, James Brown, David Piasecki and Dean Berres) winning the *Low Net Score Men's Scramble* at an impressive net of 57 strokes for each team. 2024 Mini-Grants



The Aurora East Educational Foundation has awarded almost \$300,000 in Mini-Grants over the last 10 years. During the 2024-25 school year, the AEEF awarded 20 Mini-Grants to deserving educators totalling \$21,336.80. The table on page four indicates how the various grants were used; from the purchase of Place Value Disk Manipulatives; to the purchase of tents for the Special Olympics Team; and the purchase of non-fiction Spanish language library books. The AEEF is proud to fund these grants that were used to enhance the educational experience of nearly 3,000 students, which translates to one out of four students in District 131! (cont.)

2025 Annual Donations

In addition, there were over fifty families who donated lesser amounts that were added to these endowments.

Of significant note was the death of Richard "Dick" Paul, long-time coach and educator at East Aurora High School. The outpouring of support in memory of Dick Paul was overwhelming and we are sure the Paul Family appreciates all of the kind cards and comments that were received.

The AEEF was very gratified to arrange this meeting and looks forward to connecting many more donors with students as time goes on.



2025 Scholarships Awarded

2025 was a banner year for the AEEF Scholarship Program. We were able to fund 20 Academic Excellence Scholarships, 8 Careers in Education Scholarships, 6 Careers in Technical Education (CTE) Scholarships and one 4- Four Year Scholarship. An all-time high for the three endowments the AEEF maintains, for a grand total of 35 scholarships!

Over the last ten years, the AEEF has offered scholarships and awards to 164 students. (Prior to 2025, CTE students were awarded funds by the AEEF. This process has been replaced by the CTE Scholarship Endowment.) In just the last four years, 103 scholarships and 16 CTE awards were granted. It is encouraging to see the growth in our programs over these most recent years.

The AEEF is working on growing the scholarship program by connecting with student recipients throughout the year at various events, including Honors Night, the Tom-A-Hawk Turkey Trot and inviting them to attend our Giving Tuesday Event where they can connect with donors and be recognized for their efforts.

It is common for students to receive tremendous support upon high school graduation but struggle to obtain funding in subsequent years. We intend to help bridge that gap by offering past recipients the opportunity to reapply as undergraduates. Currently, the Academic Excellence Scholarship Endowment is a one-year award available to graduating EA seniors only. The Careers in Education and CTE Endowments allow undergrads to re-apply annually.




